

April Notes

The PAC meeting scheduled for Tuesday, 14 April 2020 has been cancelled. The next scheduled 12 May 2020 meeting may or may not happen depending on the status of the COVID-19 virus.

Since there will not be a meeting in April, here are some updates from PAC:

1. Historic Route 66 stencil/grant request: The Historic Route 66 Association of AZ will be sending PAC a check for \$560 to cover the stencil and the initial road paint whenever they open back up. We will be ordering from the company who submitted a quote to us.
2. Moonset Pit: We don't know when the Pit will be opening this year. Whiz volunteered to take over unlocking/locking the gate and shade set up. Babs and John will staff the first open date in the afternoon from 11am -2pm. As soon as I have open dates, I will send out an email.
3. Liability insurance: 3 of the 4 Flagstaff insurance brokers have not gotten back to Babs since she contacted them on 3/3. We assume that we're either too small to bother with or everyone is closed down. One Flagstaff broker gave her the name of 2 insurance companies that specialize in non-profits, one in California and one in Philadelphia (one insures shooting events according to their website). Babs emailed both on 3/11 requesting a quote and neither has gotten back to us beyond a "we've received your inquiry" email. We assume they're closed down. We have decided to pay our current insurance premium right before it's due on 4/13. We can always cancel the policy if we find something better. The cost is \$343 for the year.
4. COVID-19 help: We have had no takers on PAC paying for groceries at the Parks General Store if someone cannot afford due to the pandemic. We added \$35 worth of groceries to the donation box at the Store and tipped the Deli staff \$20. On 4/1 Joanie and Babs also contacted 3 water haulers in Parks offering to pay for a water tank fill for anyone struggling to pay their bill; no takers so far either.
5. Bill Riley Memorial – The planned memorial service for Bill Riley on 4/4 was canceled and will be rescheduled for August.
6. PAC financial report for March 2020: The 2019 PAC financial audit has been put on hold.
